# ANNUAL MEETING

The Global Religious Science Ministries Annual Meeting was held January 12 at the home to President, Rev. Lisa Marks.

A discussion was held regarding the suggested by-law changes and the organizations name change.

The new name is Alliance for Spiritual Understanding (AS-U).

Also voted on and passed was the change from Commission of Ministers to Board of Directors.

A committee consisting of Rev. Doug Kinney, Rev. Robert Skenes and Rev. Dwight Smith was established to review and make a draft of the by-laws to be emailed to the Board of

Directors by February 20. After reviewing, the Board will conduct a teleconference on February 24 to discuss the draft.

Organization members will be forwarded information on the draft by-laws and a special membership meeting will be held on May 10, 2008. This meeting will allow members to provided input and ask questions regarding the changes and then vote on whether or not to accept the new by-laws.

President, Rev. Lisa gave the annual report outlining accomplishments during 2007. (see below article for list)

An election of officers was

held. Rev. Doug Kinney and Rev. Christine Coates having served 6 years as officers on the Commission of Ministers were ineligible to continue on the Board of Directors and have accepted the position of alternates on the Board. Rev. Lisa Marks remains President with Rev. Jane Weaver in the position of Vice President. Rev. Thelma Smith is treasurer and Rev. Carolyn Carlisle volunteered and was accepted as a standing member until the new by-laws are completed and other individuals can qualify to be members of the Board of Directors.

**Credentialing:** Rev. Thelma Smith, Chairperson

Credentialing Committee reviews requests for credentials, develops credentialing policies and procedures and monitors class enrollment. Makes recommendations to COM, sets up panels.

**Education:** Rev. Lisa Marks, Chairperson of Professional Development ; Education Committee is made up of several co-chairs. **To include Professional Development, Curriculum and Web Based Teaching.**

(Curriculum and Web Based Teaching Rev. Angela Peregoff & Rev. Carol Andrix are developing web based training. All requests will be forwarded to them) These co-chairs make recommendations to COM for updating curriculum, updates guidelines and text of current studies, planning and implementing Web Based Teaching and classes in Professional Development beyond Credentialed Science of Mind classes.

**Standards & Procedures:** (Need chairperson)

Researches and develops policies and procedures that keep us in compliance of GRSM, local, state and federal requirements.

**Prayer Team:** Rev. Leo Moseley, Chairperson Provides regular treatment for the organization as well as members requesting treatment. Will take the prayer team further this year by accepting requests through the GRSM web site and telephone line. Will promote the prayer team in a larger capacity than previously used.

**Fall Retreat:** Rev. Christine Coates Plan, advertise, set up and conduct annual fall retreat.

**Strategic Planning:** Rev. Christine Coates, Chairperson -Develops, coordinates and implements the seven (7) year Strategic Plan for GRSM. This is a vital step for us to take. Will determine where the organization wants to be at the end of seven years and set
